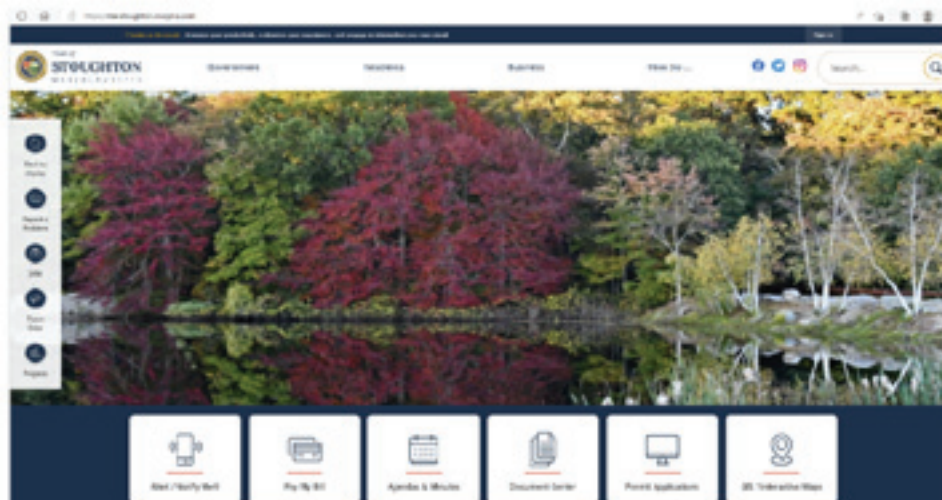

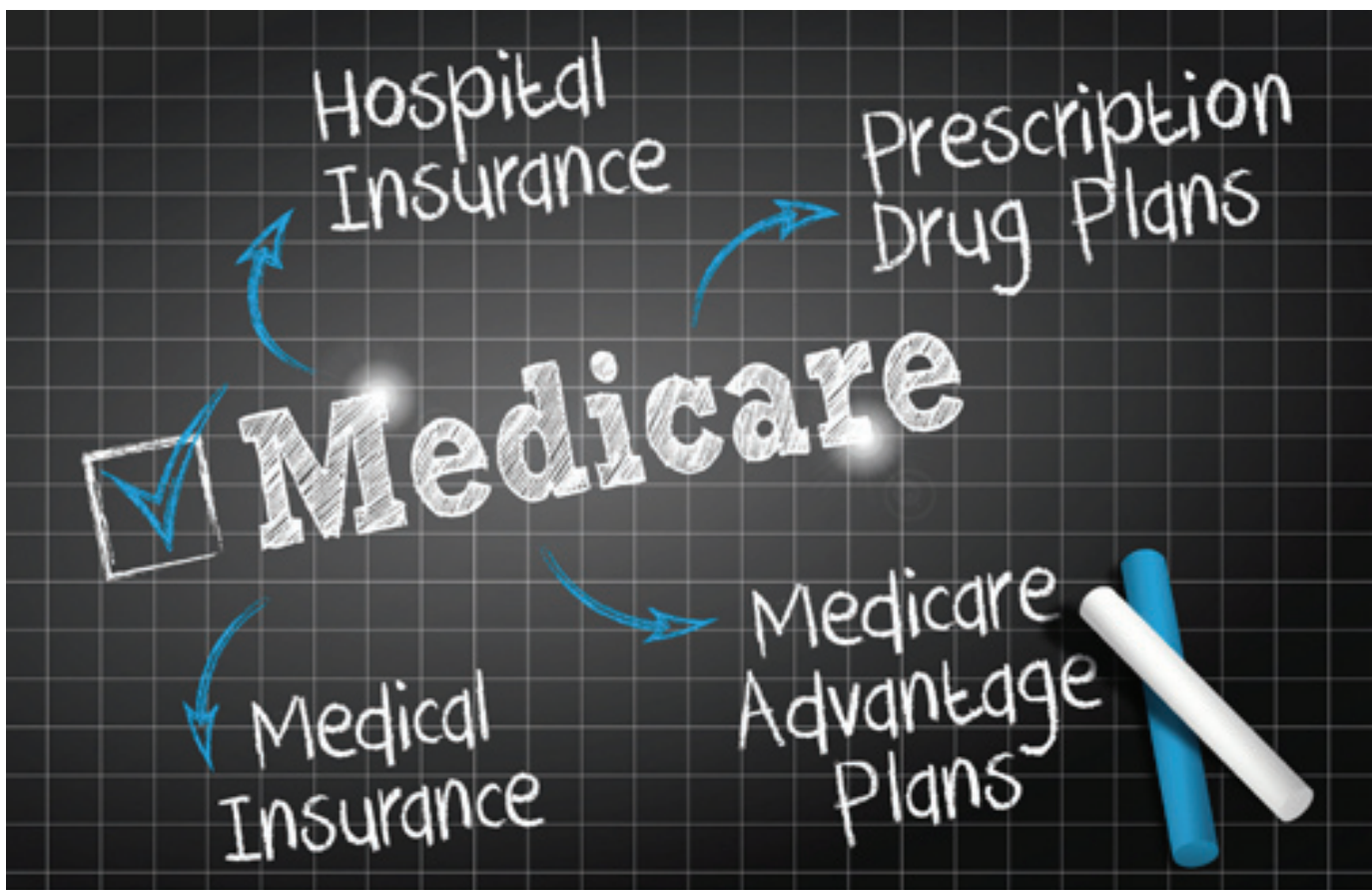

The Town of Stoughton is preparing to launch a new and improved municipal website during the month of February. Users will see not only a familiar, but improved website after going through a redesign and upgrade process with CivicPlus (a leading government website provider).

Some new features we feel you will be excited about are:

- Service-based navigation with an emphasis on service delivery and ease of use (along with a new clean design that is both visually appealing and functional)
- Calendar functionality which allows citizens to stay informed about the scheduling of important local events, including public meetings, classes, activities, community events, and other valuable opportunities for engagement
- Embedded Social Media (Facebook) – located on our front page for those who do not have Facebook accounts
- Online Job Application functionality
- Dedicated landing pages for Police, Fire, DPW, Library and Recreation
- An online “Report a Problem” form that allows users to report service requests, such as a pothole, streetlight outage, sewer issue, and more...
- Alert Center – this functionality allows us to alert citizens with time sensitive information and instructions using multiple channels, including the website homepage, social media and email
- Enhanced search functionality site-wide that allows staff to review what users are searching for and revise the site structure to continually improve the user experience
- News and page subscription options for residents to stay informed of all municipal updates
- Document Center – This will serve as a single, conveniently accessible repository for all forms, documents, and files citizens routinely require so they can self-service many of their municipal requests (without the need to walk into an office or place a phone call)
- The Agenda Center allows for the storing, sharing, and searching of public meetings and agendas and enables citizens to remain informed and engaged in public policy and local issues

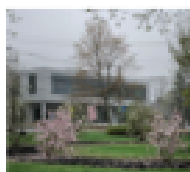

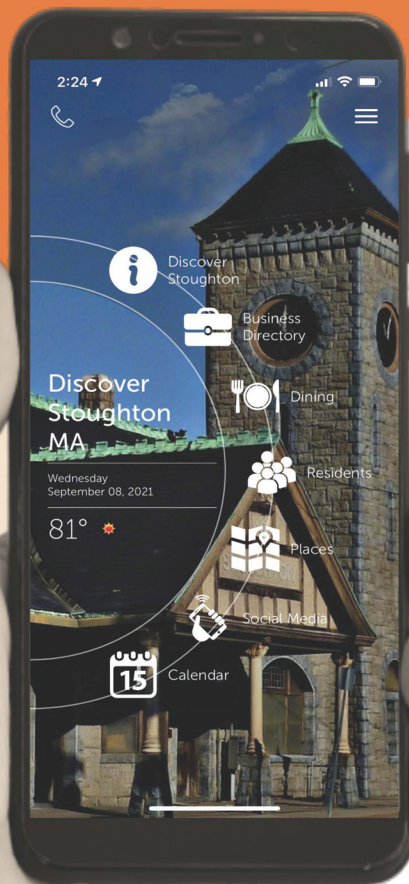

Fire Station One - New Construction Project

The Town of Stoughton, the Awarding Authority, invites sealed bids from pre-qualified and approved General Bidders and pre-qualified and approved Filed Sub-Bidders for construction activities related to the Stoughton Fire Station One Project, located at 400 Prospect Street. The project includes the construction of a new two-story fire station of approximately 25,500 square feet, including related site utilities and improvements, and a new access drive from Prospect Street. The new building will include apparatus vehicle and maintenance spaces and related storage and support spaces, workspace/work stations, and living quarters for first responders.

The preliminary estimated project construction cost is approximately \$18,000,000. DCAMM Certification is required

Prequalified Filed Sub-Bidders are eligible to submit bids for the following categories in accordance with M.G.L. Chapter 149, section 44F, which are described by the Specification sections indicated: Masonry, Miscellaneous Metals, Waterproofing/Damp/Caulking, Roofing, Tile, Acoustical Ceilings, Resilient Flooring, Painting, *Elevators (*Elevators not prequalified), Fire Protection, Plumbing, HVAC, Electrical

The Awarding Authority reserves the right to waive any minor deviation from a statutory requirement and to reject any or all General Contractors or Filed Sub-Bids if it determines that such contractors or sub bids do not represent the contractor or sub bids of a person competent to perform the work as specified; or that less than three such Sub-Bids are received and the prices are not reasonable for acceptance without further competition; or if such Sub-Bid is not one which conforms with Chapter 149, Sections 44A through 44J inclusive, of the General Laws as amended; or if such General Contractors or Sub-Bid is on a form not completely filled in, or is incomplete, conditional or obscure, or contains an addition not called for; provided, however, that the failure of the Awarding Authority to reject such a General Contractor or Sub-Bid within such period shall not validate such a bid nor preclude the Awarding Authority from subsequently rejecting it.

DO

DO's and DON'Ts of Curbside Trash Pickup

- Have trash/recycling curbside at 7AM on scheduled day, not before 4PM previous day.
- Trash must be bagged (no larger than 32-gallon barrel size) – no loose trash.



DON'T

No cleanouts – household trash only

The following items cannot be disposed of curbside:

- Yard waste
- Textiles
- Porcelain materials (toilets, sinks, etc.)
- Construction debris
- Motor parts
- Hazardous waste – oils, acids, batteries
- Tires

Please do not place the following items at curbside until you call the DPW Office at (781) 344-2112 to schedule a pickup or you can drop off these items at the DPW Headquarters located at 950 Central Street.

Fiscal 2023 Real Estate Tax Bill Error

I understand that there is some sort of error on the most recent tax bills sent out.

Do you have any information on what is going on with the error?

How did this error happen?

The Real Estate Property Tax bills for Fiscal 2023 that were mailed on December 31, 2022 displayed Fiscal 2022 assessed values in error, instead of Fiscal 2023 assessed values. This error will be rectified by producing and issuing a new bill. Any payments previously made will still be applied.

**** Please note that Personal Property Tax bills were not affected.**

Is the error higher or lower than what the bills should be?

In most cases the new and corrected Fiscal 2023 Real Estate Property tax bills will be higher.

Does this change the due dates of property taxes?

Yes, Fiscal 2023 Real Estate Property Tax bills for 3rd and 4th quarter will now have a due date of May 1, 2023. Personal Property Tax bills will remain due on February 1st and May 1, 2023.

Is the error percentage based on a flat rate off?

Neither, this issue was the wrong assessed values.

How much is the total of all the bills off?

The incorrect bill underestimated the tax liability by approximately \$7.12 million.

Is this error based on assessing?

As your Town Manager, I am accountable for the efficient operations of all departments. We have identified the cause of the error, taken action to correct it and instituted a management control system to ensure that it does not happen again.

How does this affect people that have their tax bill paid through a mortgage company?

If your mortgage company is typically notified by the Town, they will be notified of the corrected amount.

If they typically request that you provide them with a bill, you will need to provide them the corrected one.

When will corrected tax bills be received by taxpayers?

We anticipate that the corrected bill will be issued shortly. This has not been finalized yet and we will provide more details as they are available.

I apologize for the confusion this error may have caused. I assure you that we take these matters very seriously and will always endeavor to do quality work. Most importantly, I am committed to full transparency especially when we fall short of our own quality standards.
