OCCUPANCY PERMIT FOR EXISTING STRUCTURES:

Fee is based upon \$30.00/hour of time devoted to research & issue the requested permit.

RULES AND REGULATIONS:

The necessary required permits shall be obtained prior to the start of work.

Special Residential projects will be charged commercial rate.

Permit fees are payable at the time of application and are **NON REFUNDABLE** once the permit has been issued.

Permit fee calculations are always rounded up to the next thousand dollars.

Permits are not transferable.

Valuation shall be the estimated cost of construction determined by Means Construction cost data or Boca Building valuation data in effect at the time of application. It is exclusive of land value and shall include all mechanical costs associated with construction.

The Building Commissioner shall to the fullest extent provide by law, waive any and all fees due in connection with the inspections, certifications, or building permits of building owned and operated by the Town of Stoughton and/or the Stoughton Housing Authority.

Any work covered by this schedule started without obtaining the required permit will be **DOUBLED**.
