




## Are you a resident of the Town of Stoughton?






How old is the person with disabilities? (This could be yourself and/or, if you are reporting someone else's experiences, that person's age. Select all that apply)




If you have had problems accessing Town facilities, communications, programs, or services due to a disability or physical limitation, which types of problems have you experienced? (Select all that apply)


Please provide any details about problems you experienced accessing a Town facility or facilities.


Lift out of service me sidewalks uneven, cracked not level, no lift or elevator

## Which department, board, or committee offered the program or service that you had a problem accessing due to a disability or physical limitation. (Select all that apply) - Selected Choice







Town services? Does snow removal count? If so, Stoughton does a very nice job. Other than that, I do not use any Town facilities, comm, programs, or services wrt ADA.


## Have you ever made a request to the Town of Stoughton for an accommodation related to a disability?
