**Article 1 – Dissolve Stoughton VNA Enterprise Fund**

To see if the Town of Stoughton will revoke the provisions of Chapter 44, § 53F½ of the Massachusetts General Laws, ceasing the Stoughton VNA as an enterprise fund effective June 30, 2026.

**Article 2 – Transfer of Funds to South Elementary School Project to Reduce Borrowing**

To see if the Town will vote to transfer from available funds, if any, in the Treasury, to the South Elementary School Project in order to reduce the actual borrowing requirement or take any other action relative thereto.


Note: The intent of this article is to transfer the \$3,303,590 received as the last payment from the High School project to the South School project in order to reduce borrowing costs.

### **Article 3 – Supplemental Funds for Exterior of Community Center**

To see if the Town will raise and appropriate, transfer from available funds in the Treasury, borrow, or fund, pursuant to GL c. 44B, the Community Preservation Act, a sum of money to fund the historic exterior renovation of the Stoughton Community Center, formerly known as the Stoughton Depot Building, at 45 Wyman Street, Assessors Parcel 054-442, or take any other action relative thereto. Said renovation is to include exterior trim painting, landscaping, expansion of ADA parking, new public seating areas, a courtyard event space, and new planters. Said renovation also encompasses related costs including but not limited to professional services such as historic preservation, design, planning, and environmental testing, plus the cost of construction and other necessary repairs within the scope of the project as required, as well as the acquisition of materials necessary to ensure the architectural and historic integrity of the building. Funding for this article is subject to an Historical Preservation Restriction being filed with the Registry of Deeds, approval of the proposed additional trim painting from the Massachusetts Historical Commission, and a letter of support from the Stoughton Historical Commission.


