Friends of Stoughton Center Disaster Fund for Small Businesses

Fund Set Up:

- Purpose - To Raise Money to Assist Small Businesses Impacted by the Coronavirus/COVID-19 Shut Downs
- Goal - to Raise \$25,000
- Platform - Patronicity offered to help communities use their crowdfunding platform that is usually used to raise money for community projects
- The Friends of Stoughton Center was set up as a 501c3 non-profit organization; as the technical advisor for the group, Pam McCarthy, the Town's Economic Development Director made the FOSC aware of this opportunity and worked with several of the Board Members: Pam Carr, President and Dan Kelly, Treasurer to implement the fundraiser
- Fundraiser can be found at www.patronicity.com/stoughton ; link can be found on Town Website under Town News

Criteria:

- The grant funds are being disbursed according to the following conditions:
 - Business must be located in the Town of Stoughton
 - Grant is open to businesses with 15 or fewer employees; preference will be given to businesses with 5 or fewer employees
 - Sole proprietors are eligible
 - Eligible businesses must require in person contact to operate (i.e. restaurants, salons, barber shops, retailers)

- Applications are reviewed by two Friends of Stoughton Center Board members at least once/week: Pam Carr, President and Dan Kelly, Treasurer
- Emails are sent out to recipients letting them know if they are getting an award, additional information is needed or the grant is denied due to the fact that the applicant's business does not meet grant criteria

- Three largest donors:

- Other donations range from \$10 to \$500

Distribution:

- The funds are being distributed in the form of grants.
- The goal is to provide assistance in the amount of \$250 - \$500 per business depending on the amount raised.

The Paycheck Protection Program (PPP) is a loan program designed to provide a direct incentive for small businesses to keep workers on the payroll. Businesses and nonprofits employing fewer than 500 people can apply. Importantly, the SBA will forgive PPP loans if all employees are kept on the payroll for eight weeks and the money is used for payroll, rent, mortgage interest, or utilities. The program will be available retroactive from February 15, 2020, so employers can rehire their recently laid-off employees through June 30, 2020. Loans can be up to \$10M, with a 1% interest rate and a 2-year maturity; there are no payments for the first six months.

Key Points for Interested Businesses:

- Contact your lender to learn if it is participating in the SBA PPP program.
- If you don't have an existing SBA lender, use the SBA's online Lender Match Tool to identify a lender in your area.

SBA Economic Injury Disaster Loan (EIDL) Program

Small businesses, private non-profit organizations of any size, small agricultural cooperatives and small aquaculture enterprises that have been financially impacted as a direct result of the Coronavirus (COVID-19) since Jan. 31, 2020, may qualify for Economic Injury Disaster Loans of up to \$2 million to help meet financial obligations and operating expenses which could have been met had the disaster not occurred. Eligibility for Economic Injury Disaster Loans is based on the financial impact of the Coronavirus (COVID-19). The interest rate is 3.75 percent for small businesses. The interest rate for private non-profit organizations is 2.75 percent. SBA offers loans with long-term repayments in order to keep payments affordable, up to a maximum of 30 years and are available to entities without the financial ability to offset the adverse impact without hardship.

A streamlined application is now available online: covid19relief.sba.gov.

The deadline to apply for an Economic Injury Disaster Loan is Dec. 18, 2020.

The Economic Injury Disaster Loan Advance is a Loan Advance of up to \$10,000 that is available to applicants who have been approved for an Economic Injury Disaster Loan; it does not need to be repaid, so business owners can think of the Advance as a grant for business expenses.

Key Points for Interested Businesses:

- You can apply for this Loan Advance when you apply for an Economic Injury Disaster Loan (EIDL) or after you submit a loan application to EIDL.
- Declined EIDL applicants may still be eligible to receive an Advance.
- Visit the SBA's website to [submit an application](#) for the Economic Injury Disaster Loan and Loan Advance programs.

The SBA is also offering **Debt Relief** to small businesses. Under this relief, the SBA will pay the principal and interest for six months beginning March 27th, 2020 for qualifying new and current holders of 7(a) loans. Businesses who already have a covered 7(a) SBA loan or receive a 7(a) SBA loan prior to September 27, 2020 will receive this relief.

Key Points for Interested Businesses:

- Reach out to your SBA lender to discuss how this relief applies to an existing loan or to discuss applying for a new 7(a) loan.

Resources Addressing Unemployment Questions

The Department of Unemployment Assistance is moving swiftly to implement three new public benefit programs that will extend unemployment benefits for certain claimants; temporarily increase weekly benefits for all claimants; and allow additional categories of people to claim unemployment benefits. These moves follow new guidance from the federal government regarding the CARES Act.

The Department of Unemployment Assistance also hosts daily Virtual Town Hall sessions to support individuals applying for unemployment benefits in both English and Spanish. These forums are open to the public.

Federal Tax Relief Provisions

The Employee Retention Tax Credit is a tax credit against federal tax liability that can benefit almost any employer (regardless of size and including tax-exempt organizations) whose business has been either fully or partially suspended by government orders due to COVID-19, or whose revenues have been significantly impacted by the COVID-19 outbreak. The purpose of the credit is to reduce a portion of the costs of keeping employees on payroll and provide direct relief to businesses. Employers can have an effective “refund” (tax credit) of up to \$5,000 per employee by reducing their required payroll deposits. Eligibility for the credit is impacted by the business’ utilization of other federal stimulus programs.

For additional information about how this applies to your business, you should speak to your tax advisor regarding the Employee Retention Tax Credit,

Payroll Tax Deferral is another tax provision that can make a difference for employers. The CARES Act allows eligible employers to defer payment of part of their payroll taxes (which they would normally remit on a bi-weekly or monthly basis) to two larger payments; half due on December 31, 2021 and half due on December 31, 2022. As with the Employee Retention Tax Credit, this applies to federal tax liability.

What does it mean for me? While every business should consult with a tax advisor to understand how this provision applies to their particular business, the intent of this deferral is to provide relief by deferring an eligible employer's Social Security tax payments. Under the CARES Act, eligible employers do not need to pay their share of Social Security taxes for the period March 27, 2020 to December 31, 2020 until the first payment deadline of December 31, 2021. The IRS will not penalize eligible employers for not paying these taxes during this timeframe. This relief is also available to self-employed individuals for 50% of self-employed Social Security taxes.

How can I take advantage of this? Speak to your tax advisor about this provision and how it applies to your business. You may be able to hold off on remitting these payments (again, taxes for the March 27 – December 31, 2020 period) to the federal government effective immediately, until the first payment is due. The IRS should produce additional guidance on this provision.

What else should I know? You should be aware that deferring payment of these taxes may provide your business relief in the short term. Don't overlook that you will still need to pay the full amount to the federal government, spread over two years, in two lump sums.

Corporate Excise Tax penalties waived

Penalties for late-file and late-pay for corporate excise (including financial institution and insurance premiums excise) returns and payments with an original due date of April 15, 2020 will be waived if filed and made by July 15, 2020. This includes all corporate excise returns and payments with an original due date of April 15, 2020, including those of certain S corporations, banks, insurance companies and non-profits that file on a fiscal year basis.

Deadlines extended for Sales and Use Taxes, including Meals Tax

For vendors with cumulative liability for sales and use tax, including local option, under \$150,000 in the 12-month period ending February 29, 2020 (i.e., for tax collected through January 31, 2020), due dates for the filing of returns and making payments for sales, use, and meals taxes for February, March and April returns have been extended to June 20, 2020. For larger meals tax vendors that do not meet the \$150,000 threshold, there will be automatic penalty waivers for February, March and April returns filed by June 20, 2020, but interest will still accrue. The relief described in this section is not available to marijuana retailers, marketplace facilitators or motor vehicle vendors. Penalty relief for larger sales tax vendors will be considered on a case-by-case basis. Requirements for May 2020 returns and payments have not changed. Review Section 7 of the [emergency regulation amendment](#) and [Technical Information Release 20-2](#) for detailed information.

Room Occupancy Excise deadlines extended for operators

For operators with cumulative liability under \$150,000 for 12 months ending February 29, 2020, due dates for the filing of returns, and making payments, for room occupancy excise for February, March and April returns have been extended to June 20, 2020 with no penalty or interest. Requirements for May 2020 returns and payments have not changed. This does not apply to intermediaries. Review the details in subsection 11(g) of the [emergency regulation amendment](#).

Essential Services Guidance

Governor Charlie Baker has issued an [emergency order](#) requiring all businesses and organizations that do not provide “COVID-19 Essential Services” to close their physical workplaces and facilities to workers, customers and the public. These businesses are encouraged to continue operations remotely. **Governor Baker's order has been extended until May 4.**

If the function of your business is NOT listed in the guidance linked above, but you believe that it is essential or it is an entity providing essential services or functions, you **can submit an online request** to be designated as essential for the purposes of the Emergency Order.

Hotel/Motel Guidance:

As part of the updated essential business list, DPH issued new guidance around hotels, motels, inns, beds and breakfasts and other short-term residential rentals. Based on this new guidance, hotels, motels, and short-term rentals may only be used for efforts related to fighting COVID-19, like front line health workers or individuals, or for Massachusetts residents who have been otherwise displaced from their residences.

Manufacturing Emergency Response Team (M-ERT)

The leaders of the Baker-Polito Administration's Advanced Manufacturing Collaborative including Housing and Economic Development Secretary Mike Kennealy and Mike Tamasi, President and CEO of AccuRounds established the **Manufacturing Emergency Response Team (M-ERT)** to assist in the response to the COVID-19 pandemic. This work is being done in coordination with the Commonwealth's COVID-19 Response Command Center, led by Health and Human Services Secretary Marylou Sudders.

The M-ERT's Mission: To mobilize, organize, and operationalize critical path work streams necessary for Massachusetts manufacturers to pivot their operations to produce needed materials in response to the COVID-19 pandemic. A program office through the MassTech Collaborative has been established. Members have been organized into logical groups to address manufacturing supply chain issues.

Reprogramming of CDBG funds for Microenterprise Business Assistance

- Proposing that at least \$100,000 of CDBG Storefront Improvement Funds be reprogrammed for microenterprise business grants
- Originally grant was for up to 10 sign only projects and 3 full façade improvements
- To date there are 3 complete sign projects and 3 that are ready to be installed (on hold due to COVID-19 shut down of construction for retail)
- To date there is one Storefront Project that is underway located at 785 Washington Street. Project is set to go out to bid for a second time to get a new contractor to complete project (on hold due to COVID-19 shut down of construction for retail). Project had structural and ADA compliance issues.
- The program has been difficult to implement due to the fact that the condition of the buildings including structural and ADA compliance issues has caused the projects to be more expensive than anticipated
 - Once the cost of the work has reached 30% of the assessed value of the commercial portion of the building (not including any residential sections of building or land) the ADA compliance is triggered which greatly increases the cost of the project; in some cases interior rentable space would be lost in order to comply
 - The projects are expensive to begin with due to the fact that prevailing wages are required

- Despite the difficulties the Economic Development Director has tried to make the program work
- The amount of the deferred payment loan available to property owners has already had to change twice in order to make the projects financially feasible. The first change was from \$75,000 to \$85,000. The second change was from \$85,000 to \$125,000 (Public Hearing was held on 12/5/2019)
- Five Full Façade Projects Have Backed Out of the Program
 - Four of the projects had already been designed; three were ready to go out to bid; one converted to sign only
 - Four of the projects had ADA compliance issues and one had potential structural issues
 - Two of these property owners decided to sell
- Although there has been a great deal of outreach; at the present time there are not two more property owners that are interested in taking part in the program
- Given the condition of the properties even though the grant amount is up to \$125,000 there would most likely need to be a significant financial contribution from the owner. Due to the current COVID-19 crisis it would be difficult to find a property owner willing to commit money to a project at this time.

- Even if owners are found that may want to participate, they may back out later on in the process as five property owners have already done; money is being wasted on designs for projects that don't happen
- The program has already required an extension from December 2019 to June 2020 - Due to the shut down of construction, another extension is required. Extension could be used for a microenterprise program
- There are not many resources to assist businesses at the local level; other communities are also looking into converting CDBG funds for small business assistance
- Public Hearing tentatively scheduled for April 28th to present reprogramming of funds for Microenterprise Business Assistance; check Town website for confirmation. Details including program criteria will be presented

- Working On: Survey to Be Sent Out to Local Businesses to Ask them about their specific needs
